It rotates meeting in each county and is hosted by the Health Planning Board Chairman for the county in which the meeting is taking place. To date there have been no formal workgroups. However, there are two Tri-County groups that were already working on the two T-CHIP priorities. They are the Tri-County Diabetes Alliance and the Tri-County Healthy Weight Coalition. Both report on their activities at the meeting of the Tri-County Health Planning Board.

Staff work with appropriate members to draft position papers and other documents as needed. Each county has one vote. The county boards use majority of a quorum to decide what their position will be on the Tri-county questions.
