### Tasha Jamison - Program Manager, Targeted Case Management

- Has supervised the COAT team since it began in 2016. Program started within two months of receiving funding.
- Charts (shared by email prior to meeting) show numbers primarily from January to June.
- Team met to review data, and as a result of this evaluation, new data collection began in January 2020 after a review of data.
- COAT staff have worked remotely during COVID; have not been in the hospital since March.
- COAT team began contactless Narcan training and delivery in May. Training is held remotely, with touch free delivery of Narcan.
- Tasha shared a few COAT team and Narcan training success stories with the group.
- Staff have grown professionally during their time with the COAT program, and several have gone on to further their education and have advanced professionally.
- Mary Beth asked Tasha to extend our congratulations and thanks to COAT staff.
- Dr. Cockey asked for the report. Lisa Renegar shared to the group by email yesterday, and Lisa forwarded to Dr. Cockey directly.

# Prevention and Health Communications updates (Lisa shared on Cara Rozaieski's behalf)

# SCALE

- SCALE was awarded to Somerset last year. This year expanded parts of the program into Wicomico.
- Covid has impacted the program significantly. Just beginning to offer the program virtually. Program is going well, despite occasional technical glitches.
- Staff hired for SCALE had their last day with the health department on 9/28.
- MCHRC funding was extended through December 2021.
- ECI garden has been producing vegetables since June. Produce has been distributed through Pittsville Lions Club, HOPE, Inc., United Church of the First Born, MAC, Inc., Leonard Apartments, Christian Shelter, and Hudson Health. Still looking for a Wicomico garden site.

#### **Diabetes Prevention Program**

- Still in preliminary stages. In-person meetings on hold.
- CDC gave approval to provide online DPP program call HALT (Health and Lifestyle Training)
- Hope to begin in January.
- Haltdpp.org is a HIPAA compliant online platform. Allows participants to access learning modules at their convenience.
- Health department staff will be trained to facilitate HALT.

#### **Obesity Screening for Children in Dental Setting**

- Stopped due to COVID, and Chesapeake HealthCare withdrew due to other priorities.
- Village Dental Center has just reopened. Working to get started at the center.
- MDH has allowed reduction to 4 sites. Have not received responses from other providers contacted.

#### WalkWicomico

- In person walks canceled in 2020.
- New virtual event: Lower Shore Walking Tour.
- Sponsored by three lower shore health departments, and walking coalitions.
- Began October 1st in virtual format. T Shirts will be given to the first 100 to register and send in a walking selfie.
- Registration through Eventbrite.
